**PUPPIES: 3 – under 6 months, 6 – under 9 months, 9 – under 12 months, 12 - under 15 months, & 15 - under 18 months;** both sexes & Miscellaneous Classes.

Purebred Puppies 3 months and under 18 months are eligible for entry. They must be eligible for American Kennel Club registration, but need not be registered. Champions may NOT be entered in conformation classes. Wins at sanctioned matches carry no AKC championship points.

**JUNIOR SHOWMANSHIP: Beginners:** Ages 6 - under 9 years, 9 - under 18 years. **Novice:** 9 - under 18 years. **Open:** Ages 9 - under 18 years. Dogs handled in Junior Showmanship by junior handlers may be champions & more than 12 months of age.
